THE PURPOSE OF THIS AMENDMENT to alter the scope of work to allow training and consultation to conducted remotely.

## IT IS THEREFORE MUTUALLY AGREED THAT:

## CLAUSE I - STATEMENT OF SCOPE OF WORK IS AMENDED TO READ AS FOLLOWS:

The Contractor's employees, Rich Ruggiero and Christina Ruggiero, will provide 8 hours of training on January 10, 2022. The training will be conducted remotely via Microsoft TEAMS and recorded for later viewing. Training will incorporate the Alaska Oil and Gas 101 training and 102 training previously provided by the Contractor to the legislature during 2020 as well as current aspects and challenges of Alaska oil and gas. A draft of the training presentation will be provided to the Committee Chair for review and approval by January 3, 2022.

Rich Ruggiero and Christina Ruggiero will make themselves available to meet with legislators and legislative staff on January 11, 2022, for up to eight hours to answer questions or provide further explanation following the training presentations. Additional

training and consultation may be provided, if agreed to by the Committee Chair and Contractor, at the hourly rate identified in Clause III(A).

Prior to commencing work, the Contractor shall provide a cost estimate to the Project Director for the work assigned. The Project Director must approve the cost estimate before the Contractor may begin work.

Work under this Contract may not be performed by a person other than Rich Ruggiero or Christina Ruggiero. The Committee shall not be billed for work performed by a person other than Rich Ruggiero or Christina Ruggiero.
