

AMENDMENT NO. 1 TO PROFESSIONAL SERVICES CONTRACT BETWEEN

CONTRACT NOT TO EXCEED AMOUNT \$135,000
(including reimbursement for expenses)

The parties to this contract are the State of Alaska, Alaska State Legislature, Legislative Budget & Audit Committee, whose address is 120 4th Street, State Capitol, Room 3, Juneau, AK 99801-1182, hereinafter referred to as the "Committee", and PEGASUS GLOBAL HOLDING, INC., whose address is 1750 Emerick Road, Cle Elum, WA 98922, hereinafter referred to as the "Consultant".

PURPOSE OF AMENDMENT: This amendment to the November 14, 2018, professional services contract between the Committee and the Contractor extends the term of the contract and increases the amount of the contract.

IT IS THEREFORE MUTUALLY AGREED THAT:

PARAGRAPH (A) OF CLAUSE II - PERIOD AND DATES OF PERFORMANCE IS AMENDED TO READ AS FOLLOWS:

- (A) The work under this contract shall begin when the Executive Director of the Legislative Affairs Agency or her designee signs the contract and will terminate June 30, 2021.

PARAGRAPH (G) OF CLAUSE III COMPENSATION IS AMENDED TO READ AS FOLLOWS:

- (G) Total payments under this contract, including reimbursement for expenses, may not exceed One Hundred and Thirty-Five Thousand and No/100 Dollars (\$135,000.00).

CLAUSE V – ASSIGNMENT OR TRANSFER IS AMENDMEND TO READ AS FOLLOWS:

Assignment or other transfer of this contract is subject to sec. 160 of the Alaska Legislative Procurement Procedures.

CLAUSE XVI - AUTHORIZATION; CERTIFICATION IS AMENDMENT TO READ AS FOLLOWS:

Execution of this amendment is allowed by the exemption under Sec. 040(a)(1) of the Alaska Legislative Procurement Procedures and was authorized by a majority of the members of the Alaska Legislative Budget and Audit Committee at a meeting on May 10, 2019. The written justification for the exemption is attached as Exhibit A to this amendment.

The execution of this amendment by the Legislative Auditor hereby constitutes a certification that funds are available in an appropriation to pay for work performed under this contract through June 30, 2019. Availability of funds to pay for work performed from July 1, 2019 through June 30, 2021 is contingent upon appropriation of funds for the applicable fiscal year. If, in the judgment of the Legislative Auditor, sufficient funds are not appropriated for the appropriate fiscal year, the contract will be terminated under Cause II (B) without liability of the Committee for the termination, or amended.

All other provisions of the Contract as amended will remain the same.


