The parties to this amendment, made and entered into on the date the Legislative Auditor or her designee signs the amendment, are the State of Alaska, Alaska State Legislature, Legislative Budget and Audit Committee, whose address is 120 4th Street, State Capitol, Room 3, Juneau, AK 99801-1182, hereinafter referred to as the "Committee", and Wiley Rein, LLP, a limited liability partnership, whose address is 1776 K ST. NW, Washington, D.C. 20006 hereinafter referred to as the "Consultant".

THE PURPOSE OF THIS AMENDMENT to the June 13, 2018, professional services contract between the Committee and the Contractor is to extend the term of performance of the contract and to increase the amount of the contract.

IT IS THEREFORE MUTUALLY AGREED THAT:

PARAGRAPH (A) OF CLAUSE II (PERIOD AND DATES OF PERFORMANCE) IS AMENDED TO READ AS FOLLOWS:

- (A) The work under this contract shall begin June 5, 2018 and terminate June 30, 2021, unless terminated earlier as provided under the contract.

PARAGRAPH (H) OF CLAUSE III (COMPENSATION) IS AMENDED TO READ AS FOLLOWS:

- (H) Total payments under this contract, including reimbursement for expenses, may not exceed Two Hundred Twenty-Five Thousand and No/100 Dollars (\$225,000.00).

CLAUSE XVI (AUTHORIZATION; CERTIFICATION) IS AMENDED TO READ AS FOLLOWS:


Execution of this amendment was authorized by a majority of the members of the Alaska Legislative Budget and Audit Committee at a meeting on May 10, 2019.

Execution of this amendment by the Legislative Auditor hereby constitutes a certification that funds are available in an appropriation to pay for work performed under this contract through June 30, 2019. Availability of funds to pay for work performed from July 1, 2019, through June 30, 2021, is contingent upon appropriation of funds for the fiscal years. If, in the judgment of the Certifying Authority of this contract, sufficient funds are not appropriated for the particular fiscal year involved, the contract will be terminated under Clause II (B) without liability of the Committee for the termination, or amended.


